2. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: 1-(2-PHENYL-1,3-THIAZOL-4-YL)ETHAN-1-ONE >90%

3. HAZARDS IDENTIFICATION

Main hazards: Irritating to eyes, respiratory system and skin.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be irritation and redness. The eyes may water profusely.

Ingestion: There may be soreness and redness of the mouth and throat.

Inhalation: There may be irritation of the throat with a feeling of tightness in the chest. Exposure may cause coughing or wheezing.

4. FIRST AID MEASURES (ACTION)

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water. If irritation persists seek medical attention

Eye contact: Bathe the eye with running water for 15 minutes. If symptoms persist seek medical attention

Ingestion: Rinse out mouth and drink plenty of water. In case of tissue damage or other symptoms, seek medical advice.

Inhalation: Remove to fresh air. If breathing becomes difficult give oxygen and seek medical attention

5. FIRE-FIGHTING MEASURES

Extinguishing media: Suitable extinguishing media for the surrounding fire should be used. Carbon dioxide. Dry chemical powder.

Exposure hazards: In combustion emits toxic fumes.

Protection of fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Refer to section 8 of SDS for personal protection details. If outside do not approach from downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Do not create dust.

Environmental precautions: Take precautions to ensure product does not contaminate the ground or enter the drainage system.

Clean-up procedures: Sweep up, place in a bag and hold for waste disposal. Avoid raising dust. Ventilate area and wash spill site after material pickup is complete.

7. HANDLING AND STORAGE
