Subacute to chronic toxicity:

Selenium may cause amyotrophic lateral sclerosis, bronchial irritation, gastrointestinal distress, vasopharyngeal irritation, garlic odor on breath and sweat, metallic taste, pallor, irritability, excessive fatigue, loss of fingernails and hair, pulmonary edema, anemia and weight loss.

Inorganic bromides may produce depression, emaciation and in severe cases, psychosis and mental deterioration. Bromoderma, a bromide rash, often occurs when bromide inhalation or administration is prolonged. This rash is usually found on the face and resembles acne and furunculosis.

Subacute to chronic toxicity: No effects known.

Additional toxicological information: To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
